# **Procedures to Import Pesticides into Bermuda**

The Department of Environment and Natural Resources (DENR) regulates the importation of pesticides into Bermuda under to the Agriculture Act 1930. This includes pesticides and repellents for outdoor use and on livestock animals. Under the Agriculture Act, any product or substance intended for preventing, destroying or repelling any form of pests must have approval from this department prior to importation. The Department of Health (DOH) regulates the importation of all structural, interior and personal insect repellent products. The Government Veterinary Officer oversees the importation of pesticides for use on or around animals. An application form is required. Please contact <a href="mailto:animals@gov.bm">animals@gov.bm</a> for more information.

At this time the DENR office receives and processes the applications of all pesticides.

Please read and follow all of the steps outlined below **prior** to importing your pesticide product.

## **PART A: APPROVAL OF PESTICIDES**

## 1. Obtain, complete and submit an "Application for Approval to Import Pesticides":

A copy of an application form is attached below and additional copies can be obtained at <a href="https://www.gov.bm">www.gov.bm</a> or from the Plant Protection Section at the Department of Environment and Natural Resources in the Botanical Gardens. This document can also be emailed to you upon request. Please contact <a href="mailto:pesticides@gov.bm">pesticides@gov.bm</a>.

The following **MUST** be submitted to the DENR.

- a) The completed application form.
- b) A legible electronic copy of the **FULL** pesticide product label or valid link to webpage. Front and back view of label is required. (*Note: the product specification page from the catalogue or supplier webpage is NOT sufficient and will be rejected.).*
- c) A legible electronic copy or valid link to webpage of the Material Safety Data Sheet (MSDS).
- d) Payment. Fees apply for applications of conventional pesticides regulated under the Agriculture Act. An invoice will be emailed to the applicant upon receipt of the application.

The invoice must be paid before the application can be processed. Fees are below:

- \$60 for each application for a conventional pesticide for all DENR regulated pesticide products. The fee is non-refundable. (Payment of the application fee does not infer approval of the requested product).
- There is **no charge** for an application for a minimal risk/non-toxic/environmentally friendly pesticide.

## Applications will not be processed if:

- payment has not been made,
- required documentation is not provided or web links are invalid or the information is not legible,
- any fields on the application form are left blank or field information does not match the
  product. Applications received without the correct manufacturer's number (or the number
  that appears on the invoice) will not be processed.

## 2. Applications are evaluated by the DENR and/or the DOH.

Evaluation may take into consideration the applicator qualifications, intended end use, intended use location, compliance with storage requirements, health and safety concerns and suitability for use in Bermuda.

## 3. Wait for approval from the DENR or DOH.

Process time is 3 weeks. Application processing time depends on the active ingredient, prior approvals for similar products, the product formulation and the amount of research required. Every effort will be made to process the application within twenty-one (21) days, however, delays may occur due to the research required for new active ingredients, new products, emerging information on existing products which may be linked to human health or environmental problems, as well as other priorities. Once processing is complete the applicant will be advised of the disposition via email from the DENR. Authorized pesticides can be imported at that time. A 'Letter of Authority' listing the authorized products will be provided.

#### **NOTES:**

Please follow up on the status of your application by emailing <a href="mailto:pesticides@gov.bm">pesticides@gov.bm</a> if you have not received an email within three (3) weeks. Queries regarding the status of applications forwarded to the DOH (structural, interior and personal repellents) must be forwarded to <a href="mailto:envhealth@gov.bm">envhealth@gov.bm</a>.

Pesticide Seller: Importers wishing to sell pesticide products must apply for and receive written authorization from the DOH. An application form can be provided upon request.

Payment must be made within 14 days of receipt of your invoice. Invoices not paid within this time will be voided and the application rejected. New application must then be submitted.

Pesticide products regulated by the DENR and imported without receiving written authorization, even if an application was submitted prior to arrival, will be subject to a penalty of \$200 per product per import.

Once authorization has been issued for a pesticide, an importer does not need to apply again. However, an importer must reapply if the concentration, formulation, the active ingredient or the product name has changed, or the importer's information has changed (new company name, sale of company etc.)

The DENR and the DOH reserve the right to deny the importation of any pesticide, and authorization may be revoked if the pesticide is later determined to be unsuitable for the Bermuda environment or market. Authorizations may be revoked if the product is found to be used in a manner other than that specified on the application form or if the applicant is found to be applying the product in contravention to the label. Authorization of a pesticide for one importer **does not** infer authorization for all importers.

## **APPLICATION TO IMPORT PESTICIDES**

(DENR: In accordance with the Agriculture Act 1930)(DOH: Fumigation (Control) Act 1945, Pharmacies and Poisons Act 1979)

Pesticides authorized for importation by an applicant are for use by that applicant ONLY and MUST NOT be sold or distributed to or used by other individuals or companies without specific approval from the DENR or DOH.

## **PART B: IMPORTATION OF PESTICIDES**

## 4. Order the pesticides:

Only authorized pesticides listed on an importer's Letter of Authority are permitted entry. Importers must ensure that their suppliers do not substitute unauthorized pesticides in orders, even if they are very similar or generic versions of items already authorized. Penalties will be applied for unauthorized products (see below) and this may result in a delay in releasing the shipment.

## PART C: H.M. CUSTOMS CLEARANCE OF PESTICIDES (AND REGULATED ITEMS)

5. Submit the Bermuda Customs Declaration (BCD) entry for the shipment to the DENR electronically to <a href="mailto:pesticides@gov.bm">pesticides@gov.bm</a>. Paper copies are no longer accepted.

The importer or their agent must email the following documents to the DENR to <a href="mailto:pesticides@gov.bm">pesticides@gov.bm</a> (cc <a href="mailto:kmburch@gov.bm">kmburch@gov.bm</a> and <a href="mailto:acwharton@gov.bm">acwharton@gov.bm</a>) for review, approval stamp and signature - <a href="mailto:prior to submission to HM Customs">prior to submission to HM Customs</a>:

- (1) the entire BCD entry for the shipment with the CORRECT tariff rate,
- (2) the completed Summary Table (see Summary Table information below) including all regulated items (see list of regulated items below) and
- (3) the entire invoice.

## **DENR Regulated Items**:

H.M. Customs requires that records for all DENR regulated items including DENR and DOH regulated pesticides on incoming BCDs must be stamped and signed by the DENR and DOH **prior** to submission to HM Customs for clearance to verify authorization for these products. These regulated items are:

**NOTE:** Most DENR regulated items <u>must be approved for entry in advance</u> and may be confiscated if not in compliance. Be sure to contact DENR for approval and application forms in advance of the arrival of the items. For items under CPC 4215 see pages 8 and 9 below. BCDs and records for all other pesticides (structural, interior and personal insect repellent products) will be forwarded to DOH for their stamp and signature.

## **Summary Table:**

All BCD submissions must be accompanied by a summary table regardless of how many regulated items are in the shipment. Please see the sample table on the following page.

The summary table must specify:

- The full product name of the regulated item(s) being imported, product number (as presented on the invoice), quantity, cost and related invoice number (and page number where there are multiple pages of the same invoice) for each item
  - The BCD record number(s) requiring the stamp of approval and signature
- The total of each category of pesticides, potting media and fertilizers etc. (must correctly reflect the amounts in the BCD and invoices).

NOTE: Insufficient, unclear abbreviations, incomplete names, missing information or incorrect paperwork may cause paperwork to be delayed and/or rejected and the BCD will be required to be re-submitted with the correct information. All information in the summary sheet must correspond accurately with the information on the BCD and invoices otherwise corrections will be requested. DENR will not sign off on incorrect Customs Tariff codes and the paperwork will be rejected for correction.

NOTE: For those agents clearing a consolidated shipment on behalf of multiple importers, the spreadsheet can be modified to organize the entries by importer. However, please ensure that all the information has been provided in the spreadsheet(s).

## 7. The BCD paperwork will be processed by DENR/DOH.

If the reviewing officers have queries regarding the BCD, they will contact the agent or the importer or for clarification. BCDs containing pesticides regulated by the DOH will be forwarded to the DOH for their stamp and signature.

Paperwork will be processed and reviewed in the order in which it was submitted and prioritised according to lab duties, so allow adequate time for processing prior to the arrival of the shipment. Average turn-around time for BCD processing is approximately three (3) days or less if the BCD has no queries and all supporting documentation is present and accurate.

#### 8. The BCD will be invoiced.

Importers will be invoiced for BCD processing by DENR if it contains DENR regulated items that incur fees. This invoice will be emailed to the agent clearing the paperwork and must be paid in full prior to release of the signed and stamped BCD from DENR.

NOTE: Fees. BCDs for shipments containing between 1 to 5 conventional pesticides will be charged \$50 (environmentally safe pesticides \$10). BCD entries with 6 to 10 conventional pesticides will be charged \$60 (environmentally safe pesticides \$20). BCD entries with more than 10 conventional pesticides will be charged \$70 (environmentally safe pesticides \$30). Pesticides imported without authorization will incur a \$200 application fee (penalty) per pesticide and the items may be confiscated and destroyed. The importation of a prohibited pesticide will incur a penalty of \$555 and the item(s) will be confiscated and destroyed. (Fees may be increased annually. Contact the DENR for most recent fee schedule).

9. Submit the BCD signed by DENR (and/or DOH) to HM Customs for their review and processing.

NOTE: Persons wishing to bring their pesticide or other regulated item in to Bermuda via hand luggage or checked baggage must check with the airlines to determine if it is appropriate to do so as it may be considered a hazardous item. If the airline permits this method of shipping, the importer must declare the item to HM Customs at the L.F. WADE International Airport and relinquish the item to HM Customs for review by DENR. The above application and authorization process must still be followed prior to importation. The importer is not permitted to enter Bermuda with the item, even if DENR authorization has been granted. The product MUST be inspected by DENR prior to release to the importer.

## **PART D: STORAGE OF PESTICIDES**

Importers of pesticides must ensure that all pesticides are stored according to the label instructions in structurally sound, dry, secure (locked), fire-resistant, appropriately ventilated premises, with shelving appropriate for product storage.

Pesticide importers must keep accurate, updated documentation of the pesticides contained in storage on site as well as off the premises as per fire safety best practices. Persons storing large quantities of pesticides and/or fertilizers for commercial or personal use should advise the Bermuda Fire Service, the Pollution Control Section (pollutioncontrol@gov.bm) and Environmental Health (envhealth@gov.bm) to allow for appropriate emergency control measures and compliance with other regulations.

Pesticide importers must be take all reasonable precautions, particularly with regard to storage and transport, to safeguard the environment, creatures and plants, avoid the pollution of water and to protect the health of human beings.

#### PART E: USE, DISPOSAL AND TRANSPORTATION OF PESTICIDES

All pesticides must be mixed, prepared and used according to the label instructions. The applicator must follow all label health and safety instructions, including wearing of appropriate PPEs.

All pesticides and used containers must be disposed of appropriately at the prescribed disposal locations.

The importer is responsible for ensuring safe transportation and handling of pesticides and must implement appropriate containment measures when required.

The importer is responsible for all costs associated with any mitigation measures required as a result of spills, leaks and overspray, whether through negligence, improper storage or packaging fault.

## **PART F: REVOCATION OF PESTICIDES**

Pesticide authorizations are based on the information available at the time of processing. If new information becomes available that elevates the risk to the environment or other resources, or under advice from DOH regarding human health, the authorization status may be revoked with or without warning. The importer will be advised accordingly.

# <u>Importation of Goods for Commercial Food Production under CPC: 4215</u> <u>Verification Letter</u>

The Department of Environment and Natural Resources (DENR) verifies all BCD records for duty relief under CPC: 4215. See excerpt below:

## EXCERPT: BERMUDA CUSTOMS TARIFF 2020 Fifth Schedule - End Use Reliefs

**Description:** Goods for commercial food production **CPC:** 4215 **Duty Rate:** 0%

Eligible Beneficiary: All importers Qualifying goods: All goods

**End-Use Conditions / Restrictions:** 

- 1. Goods must be imported and used only in connection with the local commercial production and retail packaging of animal or vegetable products for human consumption.
- 2. Goods must be approved by the Director of the Department of Environment and Natural Resources.
- 3. In this CPC— "animal or vegetable products" means— (a) fresh meat and meat offal; (b) fresh fish and crustaceans, molluscs and other aquatic invertebrates; (c) dairy produce, birds' eggs, natural honey, and other products of animal origin; (d) fresh vegetables, roots and tubers; or (e) fresh fruits and nuts; "production" includes fishing, production by natural processes, and production by mechanical means.

Therefore all importers requesting the CPC 4215 exemption for goods imported for use ONLY in connection with local commercial production of animal or vegetable products for human consumption must produce a verification letter to **request** said duty exemption to accompany their BCD submission to this Department. [An email statement (<u>sent to pesticides@gov.bm</u>) including the information requested below is sufficient in lieu of a letter, provided the email origin can be verifiably linked to the importer involved (i.e. on file with DENR).]

Please ensure a copy of the letter is supplied to your agent for submission to DENR with the related BCD.

Please note that items listed under CPC 4215 will not be approved if it is determined that the item claimed is not directly used in connection with commercial food production. False declarations will be forwarded to HM Customs for their investigation.

The following information <u>must</u> be included in the letter/statement to DENR (example next page):

- Name, Address and Contact Information (telephone and email) of importer
- Specific information identifying each of the items requested under CPC: 4215 tariff including value as presented on the invoice and related invoice numbers
- Specific verification of end use of listed products as it relates to commercial food production (e.g. trays for use with propagation of crop vegetable seedlings e.g. roofing material for beehive construction etc.)
- Current date and signature of importer
