GENERAL INSTRUCTIONS

ALL PROPONENTS ARE REQUIRED TO COMPLETE STAGE ONE PRICING FORMS.

The Government will evaluate submissions in two stages.

Stage one is a preliminary screening phase of the pricing of the deliverables and is based on the following criteria:

- 1. Duly and fully completed forms
- 2. The inclusion of all reasonably expected project costs in each item
- 3. Competitiveness under a comparison of proponent's pricing against the Government's cost estimate

Proponents that pass this stage will proceed to the next and final stage. Annex F provides the general instructions and schedules for finalists who have proceeded to Stage 2.

SCHEDULES

Proponents shall complete both the Schedule of Values and the Schedule of Rates.

Fixed sums shall include all on-cost including all margins, contingencies, overhead and profit.

Should variations arise during the contract period, the Government will use the Schedules to determine an appropriate rate to calculate the cost of the variation. The Schedule of Rates will also be used by the Government to determine a proponent's competitiveness in pricing and probable projected final costs.

Proponents shall list each member of their team in the Schedule of Rate table, adding additional rows if required.

Proponents shall provide an all inclusive hourly and daily rate for each discipline. The Government expects that daily rates will be built up more competitively than hourly rates.

Proponents shall provide their overhead and profit percentage. This shall be added to the hourly and/or daily rate of an approved variation.
