

## **FIXED PRICE SCHEDULE**

### **CONTRACT PRICE BREAKDOWN**

(TO BE COMPLETED BY THE PROPONENT)

All prices (in Bermuda dollars) are to be all inclusive of all other associated works as shown on the Contract Documents, including materials, related accessories, storage, transport, assembly, placement, coordination w/ MPW, and overhead and profit. These rates may be used for determining additions and deletions from the contract sum and for interim payment valuation.

ITEM	DESCRIPTION	LUMP SUM
1.	Mobilization, including all preparatory work and operations necessary for the movement of personnel, equipment, supplies, and incidentals to the project site. Establishment of temporary facilities necessary for the work, premiums on insurance for the work, engagement of suppliers/subcontractors and for other operations performed or costs incurred before the beginning of the work.	
2.	Procurement of 3,000 metric tonnes of Bunker Sand, in compliance with the deliverable requirements.	
3.	Procurement of 1,000 metric tonnes of Topdressing sand, in compliance with the deliverable requirements.	
4.	Delivery of both sands to Penno's Wharf, Bermuda, including traffic management if applicable.	
5.	Customs duty/tariffs on imported material	
6.	Transportation of sand from Penno's Wharf to designated stockpiles at Port Royal Golf Course.	
7.	Demobilization, including removal from site of all plant, equipment, waste and facilities brought to site to facilitate the works, but which do not form part of the Works.
